Macomb County Community Mental Health Services (MCCMHS) is inviting responses to a Request for Proposal (RFP) for **Adult Residential Services**. The successful bidder(s) must be ready to contract with MCCMHS for Residential Services any time on or after January 1, 2018. This RFP is a re-release of a previously issued and subsequently withdrawn RFP.

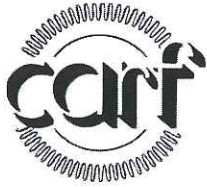
MCCMHS is seeking to **Add to its panel** of Adult Residential service providers. Therefore, new providers (or current providers) may submit bid proposals in response to this RFP. In Macomb County, MCCMHS contracts separately with landlords for the residential home itself. This RFP is seeking providers of Residential Personal Care and Community Living Supports services in the residential setting.

Please be as concise and succinct as possible with your bid documents. Your submission should provide enough information to fully describe your agency and its operations. If possible, please limit your submission to no more than fifty (50) pages (exclusive of dividers).

The input and preferences of consumers to be served by this RFP will be a significant factor in consideration and scoring of proposals received.

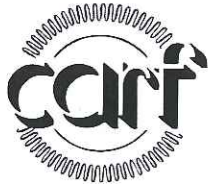
